- Work with the external affairs team to strengthen Kosmos Energy’s climate change policy and coordinate efforts to measure, reduce and mitigate carbon emissions
- Organize and manage Sustainability and ESG materiality assessments and stakeholder engagement reviews
- Research, write, and manage production of Kosmos Energy’s sustainability disclosures including the *Sustainability Report*, *Climate Risk and Resilience Report*, *Payments to Government Report* and *Modern Slavery Statement*
- Review peer disclosures and provide recommendations on how to enhance Kosmos Energy’s sustainability and ESG communications
- Review requirements for and complete ESG rating submissions (e.g. CDP)
- Engage with ESG rating agencies to capture and analyze ratings and feedback (e.g. MSCI, ISS)

- Write, edit and produce Q&A documents, talking points, presentations and other materials to support Investor Relations and update the Senior Leadership Team and Board
- Work with international offices and corporate communications to actively promote social investment initiatives, such as capacity building programs, charitable donations, environmental programs, sponsorships, and others
- Review requirements for non-financial data and engage with Business Units and Corporate functions to effectively collate data to strengthen our reporting and engagement
- Support the assurance process of non-financial data (e.g. GHG emissions, social investment)
