- Responsible for all aspects of day-to-day production operations for operated deepwater Gulf of Mexico assets
- Manage and support field personnel and third party contractors
- Monitor well/flowline performance and provide recommendations accordingly
- Develop and update Subsea Operating Procedures for producing assets
- Develop and implement flow assurance and integrity management strategies for producing assets
- Ensure regulatory testing requirements are performed on a timely basis
- Collaborate with Host Operators and Joint Venture Partners
- Participate in well workover or flowline remediation events if necessary
- Manage well unloading operations of newly completed wells to host facilities
- Prepare and present weekly presentation to management which includes reviewing actual production performance vs budgeted forecast
- Review well designs to ensure optimal completion installation for expected production environment
- Ensure health, safety, and environment are highest priority
